Re: SECOND EIR SCOPING MEETING and ERRATA to the Notice of Preparation (NOP)/Initial Study for Specific Plan No. 342, General Plan Amendment GPA No. 720, Change of Zone No. 7055 and a Development Agreement and Tentative Parcel Map

On July 21, 2006, The County of Riverside published a Notice of Preparation (NOP) for the Draft EIR No. 471 for The Villages of Lakeview Specific Plan No. 342 (SCH #2006071095). The State Clearinghouse 30-day NOP comment period runs from July 21 to August 21, 2006.

On August 9, 2006, the Riverside County Planning Commission hearing convened a scoping meeting pursuant to CEQA Section 21083.9 to receive comments on the scope of the Draft EIR. At that meeting, the Commission gave direction to Planning staff that because many working residents could not take time during the day to attend this meeting, a second meeting to receive comments on the Draft EIR scope should be held in the evening.

On September 21, 2006 at 7:00 p.m., the Municipal Advisory Committee (MAC) will hold a meeting to receive comments on the scope of the Draft EIR for The Villages of Lakeview Specific Plan 342. If you wish to comment on the scope at that time, please attend the meeting to present your comments orally or submit them in writing at that meeting.

In the NOP/Initial Study that was published on July 21, 2006, reference was made to an Appendix A on page 4. This was a typographical error. There is no Appendix A, and the NOP/Initial Study that you received represents the entire document.


